# **Privacy Policy**

Earth 300 values and respects your privacy. We collect information to provide you services, as well as to keep you updated on the progress of our project and movement. We acknowledge that we must maintain and use your information responsibly. Except for the purposes outlined below, we will not trade, share or sell your personal data with anyone.

# What personal data we collect and why we collect it

#### Comments

When visitors leave comments on the site we collect the data shown in the comments form, and also the visitor's IP address and browser user agent string to help spam detection. This also allows us to understand which country you are connecting from when you visit the website.

## Media

If you upload images to the website, you should avoid uploading images with embedded location data (EXIF GPS) included. Visitors to the website can download and extract any location data from images on the website.

#### Contact forms

If you leave a comment on our site you may opt-in to saving your name, email address and website in cookies. These are for your convenience so that you do not have to fill in your details again when you leave another comment. These cookies will last for one year.

If you visit our login page, we will set a temporary cookie to determine if your browser accepts cookies. This cookie contains no personal data and is discarded when you close your browser.

When you log in, we will also set up several cookies to save your login information and your screen display choices. Login cookies last for two days, and screen options cookies last for a year. If you select "Remember Me", your login will persist for two weeks. If you log out of your account, the login cookies will be removed.

## Embedded content from other websites

### Our use of Cookies

Like most websites, our servers automatically collect certain technical information when you visit our Website, including your IP address, browser type, browser language, the date and time of your visit, the referring URL, and, if you have visited our website before, one or more cookies that may uniquely identify your browser. We also collect information about your activities on the website, such as the pages you access.

In order to collect this information, the website places a cookie on your hard drive. A cookie is a small file containing a string of characters that is sent to your computer when you visit a website.

When you visit the website again, the cookie allows that site to recognize your browser. Cookies may store user preferences and other information. We also use web beacons and other technologies to track usage patterns.

We use several tools to collect information about use of this website. These tools collect information such as how often you visit this website, what pages you visit when you do so, what elements you interact with, or what other sites you used prior to coming to this Website. We use the information we get from these tools to improve our website, for website analysis and statistics and respond to service requests you make.

# Who we share your data with
